1. Biosecurity Australia – Inspection, GAS Treatment, ordered to Quarantine or Cleared for Delivery (Melbourne and Fremantle)

Workscope:

- 1) Discharge container from vessel to segregated quarantine stack Patrick (included in base stevedoring tariff).
- 2) Move container to inspection area and place on inspection stand Patrick.
- 3) Biosecurity Australia officer(s) to be arranged by Container Operator at its risk and expense.
- 4) One Patrick employee to assist operation in conjunction with Biosecurity Australia officer Patrick.
- 5) If treatment required for Giant African Snail (GAS) supply and lay salt/bait and monitor as required Patrick (Melbourne and Fremantle ONLY)
- 6) If any non-GAS treatment required (including BSMB), treatment to be arranged by Container Operator at Container Operators risk and expense and coordinated with Patrick terminal (Patrick may provide non-GAS services on request and subject to agreed additional costs which will be charged separately).
- When cleared by Biosecurity Australia for delivery, return import container to pre-delivery stack -Patrick.
- 8) Delivery from pre-delivery stack to Beneficial Cargo Interest road truck Patrick (included in base stevedoring tariff).
- 9) If ordered into Quarantine for wash, fumigation or other reason, container moved to quarantine area for loading to road transport Patrick.
- 10) If quarantined, lift from quarantine area to flatbed trailer for transfer to an accredited provider as arranged by Container Operator Patrick (included in the base stevedoring tariff).
 Note: Road transfer from terminal and required quarantine services to be arranged with an accredited quarantine provider within the port precincts (as directed by Biosecurity Australia) by Container Operator at Container Operator risk and expense (required services may include but are not limited to container lifts to/from road truck, baiting, monitoring, wash or fumigation outside of terminal).

Inspection and Cleared

Items 2 + 4 + 7; AUD 261.45 per 20ft/40ft ISO container + GST

Inspection, Treatment for Giant African Snail ONLY and Cleared

Items 2 + 4 + 5 + 7; AUD 261.45 per 20ft/40ft ISO container + GST

plus any additional handling and storage charges if applicable

Inspection and Ordered to Quarantine

Items 2 + 4 + 9; AUD 261.45 per 20ft/40ft ISO container + GST

plus any additional handling, storage and on-terminal treatment charges if applicable

Other services

Tarping, Fumigation, separation and inspection of Flat Rack nests or any other services required to be undertaken on the terminal at the request of Bio-security Australia – POA via respective terminal

2. Biosecurity Australia - Inspection and ordered into Quarantine or Cleared for Delivery (Sydney Autostrad)

Workscope;

- 1) Discharge container from vessel to segregated quarantine stack within Sydney Autostrad Terminal Patrick (included in base stevedoring tariff).
- 2) Move container to inspection area and place on inspection stand Patrick.
- 3) Biosecurity Australia officer(s) to be arranged by Container Operator at its risk and expense.
- 4) One Patrick employee to assist operation in conjunction with Biosecurity Australia officer Patrick.
- 5) If any treatment required (including GAS or BSMB), treatment to be arranged by Container Operator at its risk and expense and coordinated with Patrick terminal.
- 6) When cleared by Biosecurity Australia for delivery, return import container to pre-delivery stack Patrick.
- 7) Delivery from pre-delivery stack to Beneficial Cargo Interest truck or transfer to on-dock rail terminal Patrick (included in base stevedoring tariff).
- 8) If ordered into Quarantine for wash or fumigation, container moved to quarantine area for loading to road transport Patrick.
- 9) If quarantined, lift from quarantine area to flatbed trailer for transfer to an accredited quarantine provider, within the port precincts Patrick (included in the base stevedoring tariff).

 Note: Road transfer from terminal and required quarantine services to be arranged with an accredited quarantine provider within the Port Botany precinct (as directed by Biosecurity Australia) by Container Operator at Container Operator risk and expense (required services may include but are not limited to container lifts to/from road truck, baiting, monitoring, wash or fumigation outside of terminal).

Items 2 + 4 + 6; AUD 261.45 per 20ft/40ft ISO container + GST.

Inspection and Ordered to Quarantine

Items 2 + 4 + 8; AUD 261.45 per 20ft/40ft ISO container + GST

Other Services

Wash Cost – service provided by others

Fumigation, Tarping, or any other treatments – service provided by others

1. Biosecurity Australia - Inspection and Cleared for Delivery

Patrick inclusions and workscope;

- 1) Patrick Terminals to place affected containers into the CargoLink exchange area (included in base stevedoring tariff)
- 2) Movement of container from CargoLink exchange area to processing/storage area.
- 3) Supply and lay salt/bait for Giant African Snail (GAS) and monitor all areas involved in process.
- 4) Internal movements of containers within CargoLink site.
- 5) Biosecurity Australia officer(s) to be arranged by Container Operator and attendance coordinated with site to carry out inspection.
- 6) Supply employee to assist operation in conjunction with Biosecurity Australia officer.
- 7) Place container on inspection stand and carry out inspection.
- 8) Return cleared container to pre-delivery stack when Biosecurity Australia cleared.
- 9) Delivery of container to nominated carrier on presentation of approved documentation.

Rates: Patrick CargoLink

AUD 261.45 per 20ft/40ft ISO container + GST.

If any affected containers are allocated to a temporary stack position within the ocean terminal for inspection, GAS treatment and/or later transfer to the CargoLink exchange area, the supply and laying of salt/bait and monitoring is to be undertaken by an outside pest control contractor arranged by Container Operator at its risk and expense.

Plus any additional terminal yard lifts at AUD 148.80 per 20ft/40ft container + GST.

2. Biosecurity Australia - Inspection and ordered into Quarantine and External Wash

Patrick inclusions and workscope;

Patrick Terminals to place affected containers into the CargoLink exchange area – included in base stevedoring tariff.

- 1) Movement of container from CargoLink exchange area to processing/storage area
- 2) Supply and lay salt/bait and monitor for Giant African Snail (GAS) if required in all areas involved in process other pests.
- 3) Internal movements of containers within CargoLink site.
- 4) Biosecurity Australia officer(s) to be arranged by Container Operator and attendance coordinated with site to carry out inspection.
- 5) Supply employee to assist operation in conjunction with Biosecurity Australia officer.
- 6) Place container on inspection stand and carry out inspection.
- 7) Perform cleaning function as directed by Biosecurity Australia officer (includes employee(s), use of platform, use of wash bay and supply of water, cleaning materials and waste disposal.
- 8) Biosecurity Australia officer re-inspects container.
- 9) Cleared container returned to pre-delivery stack when Biosecurity Australia cleared.
- 10) Delivery of container to nominated carrier on presentation of approved documentation.

Rates (External Wash):

2.01 AUD 406.10 per 20ft container + GST

2.02 AUD 595.20 per 40ft container + GST.



3. Fumigation of Containers;

Patrick inclusions and workscope;

- 1) Move container from inspection area to Fumigation area.
- 2) Arrange fumigators to attend site to carry out fumigation, fumigate/monitor at Giant African Snail (GAS) rate 128 grams per cubic metre or as otherwise ordered by Biosecurity Australia.
- 3) Remove cleared container from Fumigation area and place on wash bay for re-inspection.
- 4) Cleared container returned to pre-delivery stack when Biosecurity Australia cleared.
- 5) Delivery of container to nominated carrier on presentation of approved documentation.

Rates:

3.01 AUD 723.15 per 20ft container + GST. **3.02** AUD 1,195.95 per 40ft container + GST.

4. Biosecurity Australia affected containers - any other services required other than those outlined above (including transhipment containers); Price on Application.

5. Exclusions:

- 1) Biosecurity Australia officer attendance at site to be arranged by Container Operator at their risk and expense and coordinated with Patrick CargoLink
- 2) Additional treatment for pests/quarantine requirements other than Giant African Snail (GAS) (such as BSMB) subject to price on application.
